#### **OLD BUSINESS:**

- 1. **Status of dogs belonging to Swett:** The ACO, Butch Pinkham, filed an ex parte with the Court. Mr. Swett needs to attend the hearing May 7<sup>th</sup> to give a reason why the dogs should be released to him. At present, total owed by the Town has accumulated to \$1560.
- **2.
