1. **PRSWDD Agreement:** Selectman Harry Fish made a motion to confirm accepting the last proposal Selectmen Dwight Alley seconded it with no discussion. All in favor. Selectman Harry Fish made a motion for Dwight Alley as the chairman to sign the agreement. Selectman Wm. Milliken seconded no discussion all in favor. 2. **Kristian Crowley, Medical Marijuana fees:**
