### NEW BUSINESS:

- 1. Maine Harbor Master Association:** This is a computerized & smartphone Harbor Management and Communications Log System. The info was also forwarded to John Church. The Town is not ready for this upgrade, may be in the next few years.

- 3. Sawyer Square:** No update.
- 4. PRSWDD Agreement:** No correspondence has been received from Kate since the agreement was signed and a check mailed for PRSWDD.
- 5. Stillman Creek/Kelley Pt Rd:** The office received an Invoice from Dirigo, a down payment of \$22,000 was sent. A withdrawal was requested from the grant in the amount of \$49,860., the cost of the bridge.
- 6. WCSO:** Memorandum of Understanding needs a signature. Selectman Alley will come to the office tomorrow and do that.
- 7. Sandy River Beach:** Dennis Moraisey said he was waiting for the area of Sandy Beach to get less busy before he could do the work to the concrete planks. He said it would be fine if the Town found someone else to do the work.

8. **John Hamer:** An email was received from Attorney Hamer in regard to Roque Island. The Selectmen requested that any decision be postponed until next week when Selectman Milliken would be in attendance.

9. **Recoup poverty abatements:** MMA reported that over the years, a number of attempts have been made to the Maine Legislature for its endorsement, but claims that poverty abatements are governed by an entirely separate statute. Liens can be authorized under certain circumstances to recover GA expenditures,
