NEW BUSINESS:

1. **Marc Perry:** Selectmen signed Certificate of Appointment and also the Assessor’s Contract
2. **Tim Tabutt - WCS:** over budget with last billing this billing takes us over \$7,928.62 paid \$1,541.00, Selectmen Milliken made a motion to half the difference of overcharges on the contract-\$3200.00. The funds are to be taken out of contingency funds. The selectmen give authorization to continue for two details each week covering to the end of the fiscal year (June 30, 2021). Selectmen Fish accepted the motion with Selectmen Alley seconded. All in favor. {explanation \$3,200.00 for overcharge on coverage, 2 details each week, @ \$250 detail x 6 weeks = \$3,000.00, with an total estimate of \$6,200 being paid out of contingency for the 2020/2021 fiscal year.}
