NEW BUSINESS:

- 1. Oil slick on Sawyer Square: East side of the square at the corner of Main Street; #2 Sawyer Square. The Code Enforcement Officer, Betsy Fitzgerald will be notified by the Selectmen's Office so appropriate action can be taken.
- 2. Storm Drain across from 269 Main St: The flow from the storm drain is running through a weak pipe, under the road and driveway of 269 Main Street (Gawkowski property) causing problems in the driveway and draining into the backyard of the property. The property owner has called D.O.T as this is a State Road but calls have not been returned. Selectmen's Office will call D.O.T. and ask that the property owner be contacted.

OLD BUSINESS:
