### NEW BUSINESS:

1. **Planning Board alternate selection, 1 M.R.S.A. § (405)(6)(A) executive session:** Selectman Milliken made a motion to go into executive session, seconded by Selectman Fish, to discuss the appointment of two alternate members of the Planning Board at 4:05 pm, they returned to the regular session at 4:10 pm. Selectman Fish made a motion, seconded by Selectman Alley to appoint Diane Smith and Bill Nunan as the alternates.
2. **Jim Carver report on roads and bridge:** Jim Carver reported on Norton Circle and Lamson Road. They need additional gravel, which is standard work, with the pavement rolled up and then placed back down. Alexander Avenue needs gravel to build the road up and three inches of pavement because the road is partly under water. Feeney Street needs a rebuilt road; it's the only way to address the issues. Jim will get figures to the office in time for the June town meeting. Jim also gave an update on the bridge. He thinks he can take delivery in three to four weeks. Because the cost of materials increased, he also will give an estimate to finish the groundwork.
3. **Interview for Local Emergency Officer, 1 M.R.S.A. § (405)(6)(A) executive session and review other applications:** Selectman Fish made a motion to enter into executive session and review applications for the Local Emergency Office at 4:44 p.m., seconded by Selectman Alley. There were two interviews and a third is scheduled for next week. They returned to general session at 4:58 pm.
4. **Lee Guptill's resignation from the Comprehensive Plan and Economic Development:** Selectman Fish made a motion to accept Lee Guptill's resignation from the Comprehensive Plan and Economic Development Committees with extreme regret, seconded by Selectman Alley.
