NEW BUSINESS:

1. **AFLAC presentation:** Selectman Fish made a motion to fully support the AFLAC plan for the town employees, seconded by Selectman Alley. Chrissi Prue will be in touch with employees later.
2. **Updated report on grant for Henry's Point:** Senator Collins has approved 1.5M for the Henry's Point project. There are more steps, but the funding looks very promising.

OLD BUSINESS:

3. **Advice from Attorney, Moratorium Regarding the Development and Operation of Commercial Aquaculture Facilities Petition & Amendment to the Recall of Elected Municipal Officers Ordinance:** Selectman Milliken suggested that the affidavits accompanying the two petitions, be completely rewritten, Anson Alley, who gathered the signatures asked that the affidavits stand with just his initials. Selectman Fish made a motion to accept the affidavits with just initials, seconded by Selectman Alley.


4. **Jim Carver unable to attend, re: road repairs:** Jim will be asked to attend the next meeting, if he is unable to, ask for an estimate on the town roads for an article in a special town meeting to be held later. Also, ask about delivery of the bridge for the Kelley Point Road.

MISCELLANEOUS:

5. **Advice of Local Health Officer:** Sam Hunkler, the local health officer, has checked the runoff of water on Feeney Street; he was not able to detect a smell of sewage. Kathy Killian is coordinating with a landowner on the street to get funding for a proper sewage system. Dr. Hunkler inspected an area on Hopkins Point Road. There is a massive amount of trash. At present, he sees no health risks, but the potential is there. Selectman Fish made a motion to have a demand letter drafted, giving the landowner 30 days to clean up the trash and allowing Selectman Milliken to sign it on behalf of the Board. Selectman Alley seconded the motion.

Selectman Milliken reported he took care of complaints regarding Campground Road and there was a thank you received for the Duck Crossing sign posted near the skating pond.

Motion made by Selectman Fish Seconded by Selectman Alley to adjourn the meeting at 5:00 p.m.
