NEW BUSINESS:

1. **Solar Panel Committee interview 1 M. R.S.A.§ 405(6)(A):** Selectman Milliken made a motion, seconded by Selectman Fish to go into executive session to interview Rick Crouthamel at 4:35 pm. At 4:46 p.m. Selectman Milliken and Selectman Fish returned to the general assembly. Selectman Fish made a motion, seconded by Selectman Milliken, to approve Rick Crouthamel as a member of the Solar Panel Committee.

OLD BUSINESS:

- 2. **Magur Request:** Gary and Colleen Magur requested the Selectmen be asked what benefit there would be for them to allow bridge parts to be placed on their lot at 1 Kelley Point Road. The Selectmen reported the lot would be mowed and cleaned up afterward.
- 3. **Versant Power-16 Breeze Street:** Selectmen Milliken recused himself from this item because of conflict of interest.
