NEW BUSINESS:

1. **Sidewalk Sand Clean Up:** Jonathan MacLeod of SnowBeGone has a 3-year contract and has quoted \$3,602.00 to clean up sand from Main Street and Sawyer Cove sidewalks. Last year was \$3,000.00 It is almost time to expect fall and winter sanding to begin again. Motion made by Selectman Fish, seconded by Selectmen Alley to have Mr. MacLeod do the cleaning in Spring 2023. Motion approved.
