
1. **MDOT Planning Partnership Initiative:** Jarod Farn-Guillette of the MDOT Planning Partnership Initiative, went with a ride through downtown with the Selectmen to view the Main Street. There is concern that any more infrastructure downtown will overburden the area. Jarod will draw up a plan through the MDOT Planning Partnership Initiative now that he fully understands the challenges on Main Street.
2. **Sliding Hill update:** Dwight Smith, Jr. has been notified to widen the sliding hill and clean up the part that might have overgrown this summer.
3. **Alcohol Referendum:** Selectman Milliken made a motion to have the Alcohol Referendum contain option #1 and #3, seconded by Selectman Fish.
4. **Engineer for road projects:** Selectman Milliken reported that Dean Bradshaw would be a consultant on the various road projects in Town. Milliken and Bradshaw will discuss the projects on September 9<sup>th</sup>.
5. **Snow Removal contract 2022-23, 3% increase:** Selectman Fish made a motion to offer contract to William Look dba Sid's Inc. with the 3% increase. Selectman Alley seconded the motion.
