## **NEW BUSINESS:**

1. **Jewett Road and Short Road updates-Dan Lozaro:** Dan Lozaro did not attend the Selectmen's meeting as expected. The Selectmen reported there is \$500 for use on the Jewett Road for repairs so clammers can access the beach. There are no funds other than that available for private roads.

## **OLD BUSINESS:**

- 2. **Alcohol referendum, what's next:** The next step is the State to issue a permit to the restaurant. After that, an application be submitted to the Town by the business who wants to sell liquor in a restaurant; This application must include an annual spreadsheet before the Selectmen will reissue an application each year. Another referendum ballot will be included in the June 2023 election to allow/disallow sale of liquor by a restaurant on Sunday.
- 3. **Report from Solar Ordinance Committee:** The Solar Ordinance Committee Chairman, Bill Nunan, asked for a second extension on the Solar Ordinance Moratorium which expires January 8, 2023.

## MISCELLANEOUS and FYI:

4. **Broadband Update, report from Mr. Collins:** Mr. Collins, Superintendent of Schools, reported that 53% of students eligible for free or reduced lunch submitted their applications from the High School. Jonesport Elementary had applications returned by 82 of the 100 students. Of those, 47 qualified for free or reduced lunch.

- 12. Versant Power will be contacted to ask about the LED lights that were promised to Jonesport for streetlights. The streetlights were never replaced.
- 13. Selectman Milliken made a motion to approve a request submitted by the assessor, Marc Perry, to write off a lien from the previous year, 2021, including all associated fees, for the benefit of the Moosabec Ambulance. Selectman Fish seconded the motion. Motion carried.
