NEW BUSINESS:

1. **Quit Claim Deed-Cove School:** Selectperson Fish made a motion to sign the deed releasing all interest the Town may have in the Cove School. Selectperson Alley seconded the motion.

OLD BUSINESS:

2. **Village Partnership:** Jarod Farn-Guillette will be attending the Selectperson meeting on July 19th.
3. **Articles for Town meeting warrant:** Selectperson Fish made a motion to approve the articles for the Special Town meeting on June 21st, to be held after the public hearings scheduled for the same evening at 5:00 p.m. Selectperson Alley seconded the motion.
4. **Follow up from Selectboard member Alley, i.e. Mr. Nowak's well issue on Polk Lane:** Selectperson Alley reported that Joe Cifelli, the plumbing inspector, cut the pipe coming out of the basement of the house where a sump pump was pumping water. This seemed to help a lot but didn't completely solve the problem. The remaining water could be coming from run off from the ditch across the street because Mr. Nowak's house is downhill from the street.
5. **Camper on Jonesport Ave (Lamson/Look):** Selectperson Alley made a motion to have Attorney Hamer write a letter to Mr. Lamson, outlining his options. Selectperson Fish seconded the motion.

MISCELLANEOUS and FYI:

6. **The office received a call from Wendy Robinson in reference to a broken septic pipe going to her property:** Carver Construction is working on Feeney Street and will replace the broken pipe, but this will not solve the issue of no leach field.
