- 1. **Kingfish report:** Selectperson Fish made the motion to refer the Kingfish report to the Planning Board for their consideration and public hearing, seconded by Selectperson Cilley. After public hearing, the Town can decide time to start project.
- 2. Open bids from Cemetery/Parks Mowing: Tabled.

OLD BUSINESS:

- 3. Authorize ad for Richardson Cemetery bids: The permits for the work will be received by next week.
- 4. **Bid proposal for Veterans Memorial and Richardson Cemetery:** Selectperson Fish made a motion to put the RFP for proposal, with conditions, in the MVNO; seconded by Selectperson Alley.
- 5. **Street sweeping:** Dwight Smith sold his equipment to Luke Hunkler. The contract with Dwight was \$3000. Luke will take over the street sweeping for the same cost.

MISCELLANEOUS and FYI:

6. **Approve Campground purchase of 10x16 storage shed:** Selectperson Fish made the motion to approve purchase of a 10x16 shed for the campground for \$4,200; seconded by Selectperson Alley.

- 7. **Request by Jarod Farn-Guillette to meet with Select Board via Zoom:** Selectperson Fish made the motion to have Jarod meet with the Select Board either the 4th or 18th of June; seconded by Selectperson Alley.
- 8. **Boyde Crowley report:** The Select Board authorized Boyde to spend part of the insurance funds for necessary equipment, approximately \$113,000. The remaining funds are to be put into account for necessary improvements in the future.
- 9. The School Budget meeting will be held on May 21st at 6;15P.M. in the JES gym. The Select Board will have 3 articles on the warrant: approve the food ordinance as written, take \$5,000. out of surplus to close up the 46 Main Street building from the elements and Bimbo Look called during meeting to ask for reimbursement for plowing Maker's Point Road. He stated he plows about 17.5 miles of road and Maker's Point added another 1 mile to his contract. Selectperson Fish made a motion to put these three articles on the school warrant and Selectperson Alley seconded his motion.
