### **NEW BUSINESS:**

1. **Mowing needed at the skating pond and 46 Main Street:** Selectperson Fish made a motion to hire Joseph Perkins to mow the Skating Pond for \$35 per mowing and to mow the Norton Community Center lot for \$50; seconded by Selectperson Cilley.
2. **Flake Point Bar Access Letter:** Selectperson Fish made the motion to approve the office staff writing a letter to a citizen asking the status of Flake Point Bar. After research it is determined that the access road is actually a right of way owned by numerous people but can still be used to access Flake Point Bar for general use, such as clamming, picnics etc. The motion was seconded by Selectperson Cilley.

### **OLD BUSINESS:**

3. **Discuss bids received for Tennis/Basketball courts:** Bids had been received previously by four contractors but after consideration the Selectboard decided to break the project into steps. The first step is to cut back alders and widen the road to the courts and cut around where the parking lot will be. Three new bids were received for just that part of the project. Selectperson Fish, seconded by Selectperson Cilley made the motion to approve the \$6,800 bid for the first step in the revitalization of the courts. The contract was awarded to Nick Faulkingham.
4. **Jarad Farn-Guillette, Downtown revitalization:** After discussion with Jarad, the selectboard decided to go with a feasibility study to determine what would be the best way to rehabilitate the sidewalks in town. The project is Village Partnership. The cost will be \$80,000 of which the Town will be responsible for 30%. Selectperson Fish made a motion to proceed with the project; seconded by Selectperson Cilley.

5. **Mr. Swain-JES budget:** The warrant and back up will be posted on Monday for the July 16<sup>th</sup> JES budget meeting at 6:15p.m.
