### **NEW BUSINESS:**

- 1. Jarad Farn-Guillette, Downtown revitalization:** Discussed need for a study committee. Both Irene Rogers and Cynthia Beauvais have volunteered to be on the committee.
- 2. Andrew Mulholland, West Surveying:** A motion was made by Selectperson Fish and Selectperson Alley for a letter to be sent to Mr. Mulholland stating that West Wind Road is not a Town road.

### **OLD BUSINESS:**

- 3. Discuss regarding Tennis/Basketball courts:** A motion was made by Selectboard member Fish and seconded by Selectperson Alley to put out an RFP for refurbishing or replacing the surfaces of the tennis and basketball courts and possibly replacing the fencing.
- 4. Marquee for Skating Pond:** Motion was made by Selectperson Fish and seconded by Selectperson Alley to purchase a marquee sign for the Skating Pond not to exceed \$3000.00 to be paid from ARPA funds.

### **MISCELLANEOUS and FYI:**

- 5. Fire Road pavement:** A motion was made by Selectperson Fish and Seconded by Selectperson Alley to look at the balance in the Roads Account and to get an estimate for the road surface to be dug out and a new hot top surface put in place.
- 6. Request to extend the payment of property taxes for account #466:** Approval was signed by Selectpersons Fish and Alley.

8. **Cogswell Street issue with potholes per postmaster:** Ask Bo Beal look at it and see what is needed.
9. **Warrant preparation for Special Town Meeting for July 30<sup>th</sup>:** Select board will have a Special Meeting tomorrow at 2:00 PM to sign the warrant.
10. **Makers Point Road:** Sheila Millette brought up a complaint that the Maker's Point Road is so narrow that two cars can't pass when they meet. Selectboard member Fish will check it out.
11. **Selectboard resignation:** Selectboard member Alley advised that he plans to resign from the Selectboard.
