
**ARTICLE 1.** To elect, by ballot, a Moderator to preside at said meeting.





**SCHOOL COMMITTEE MEETING MINUTES**


PLEASE NOTE THAT THE MINUTES ARE NOT FINAL UNTIL APPROVED AT THE NEXT MEETING
