SPECIAL TOWN MEETING WARRANT

JONESPORT-BEALS HIGH SCHOOL

To: Howard Mills, resident of the Town of Jonesport, in the County of Washington, State of Maine.

Greetings: In the name of the State of Maine, you are hereby required to notify and warn the Inhabitants of the Town of Jonesport, qualified to vote in Town Affairs, to assemble at the Jonesport-Beals High School on Snare Creek Lane, in said Town on Wednesday, the 20th (twentieth) day of July 2022, at 6:00 p.m. to act on the following articles, to wit:

ARTICLE 1: To elect, by ballot, a Moderator to preside at said meeting:

ARTICLE 2: To see if the Town will approve the Aerospace Ordinance as written.

ARTICLE 3: To see if the Town will authorize the Selectmen to borrow up to \$200,000 from surplus for road repair, with the payback over 3 years and 1% interest. (FYI: Alexander Ave., Lamson Lane, Feeney Street, and Norton Circle)

ARTICLE 4: To see what sum the Town will raise and appropriate to both the MLA and MLU. The Selectmen recommend \$5,000.

ARTICLE 5: Shall a Moratorium entitled "Moratorium Regarding the Development and Operation of Commercial Aquaculture Facilities within the Town of Jonesport, Washington County, Maine" be enacted?

ARTICLE 6: Shall Section 3a of the Ordinance entitled "Recall of Elected Officers Ordinance of the Town of Jonesport" be amended to reduce the number of voter signatures required on a petition for Recall to "at least 10% of the number of votes cast in the town at the last gubernatorial election?" (FYI: Section 3a now reads: *The petition for recall must contain only signatures of registered voters of the Town of Jonesport. The number of signatures shall equal at least twenty-five percent (25%) of the total number of registered voters of the Town of Jonesport as of the preceding municipal election, but no fewer than 100.*)

ARTICLE 7: Shall the Town authorize the Selectmen to withdraw an amount (not to exceed \$10,000) to use for securing an LMF covenant at Henry's Point?

The Board of Selectmen gives notice that the Registrar of Voters will be in session for the purpose of correcting the voting list and registering new voters at the Jonesport-Beals High School on the 20th (twentieth) day of July 2022 at 5:45 p.m. Given under our hands in the Town of Jonesport, Washington County, State of Maine, 10th (tenth) day of July 2022.
